National and state networking events

Are you aware of the variety of national, state, and local networking events available to business owners to meet and share information? I've been a member of Business Network International for many years. They have chapters throughout the world. Every city of any size will likely have a local chapter you could visit. Check the website BNI.com to find a chapter near you. At each meeting, members are given an opportunity to give a short commercial from 30 seconds to one minute depending on the number of members. Each meeting also has education moments where networking tips are given. Some meetings are all in person while other chapters have a mix of in person and virtual meetings. There are also regional and national conferences where you can network with others throughout the area or the nation as well as internationally.

Another national organization with chapters in most areas of the country is the American Business Women's Association. If there is not one in your local community, there are many now which have virtual meetings so you can join the closest one to you. They also hold regional and national conferences with lots of business related information. After I moved to Colorado, I joined the Pathfinders chapter in San Francisco since they were on Zoom and there were no chapters in CO. Monthly meetings have speakers on a variety of topics for business

owners to learn. You also can introduce yourself and your business.

I belonged to a local Chamber of Commerce in cities where I lived as well. It's a great way to know what is going on in your local community and for local businesses to meet you. I urge you to search for other networking opportunities in your community. Even if you don't wish to join any of these organizations, it is good to visit them.

### IVIE "Entrepreneur Exchange" Call Tips and IVIE Email Discussion Posts

Some of the valuable information learned at the recent "Entrepreneur Exchange" calls are below. On the November 12 call, "Finding the right sighted assistance for digital design and other visual needs" was the focus. Some found BeMyEyes and AIRA helpful for many tasks; others found sighted assistants through church and other networking organizations, and others used online sites such as "YELP", Angie's list, and others. It was suggested to have a list of skills you need before interviewing possible helpers.

The January 14 call was on "Setting realistic goals". Ron Brooks was the presenter on this topic and he gave his goal setting strategy. Others commented on how they set goals as well so participants received some good tips to keep their businesses on track.

On February 18, the topic was "business tax focus". Beneficial Ownership: how many of you have heard about this? One of the most important items mentioned was on the new Beneficial Ownership Reporting Requirements. All

entrepreneurs need to be aware of these new requirements resulting from the passage of the Corporate Transparency Act. As of January 1, 2024, any "corporations, limited liability companies, and any other entities created by the filing of a document with a secretary of state or any similar office in the United States," are required to register their businesses with Financial Crimes Enforcement Network (FinCEN). It should be noted that a retail vending business would NOT appear to fall into any of the exempted categories. If you started your business after January 1, 2024 you have only 90 days to submit the report. If your business was started before January 1, 2024, you have until December 31, 2024 to file. It is a simple form to file so shouldn't be difficult to comply. To read all the details, go to https://www.fincen.gov/boi

There are stiff penalties for noncompliance. The direct link for filing is: boiefiling.fincen.gov/fileboir

Other suggestions on the call were using accessible tax software such as taxactonline.com or Intuit's Turbotax.com.

A benefit of having an Office 365 subscription is often under the radar for most people. It is one included in the

subscription benefits - the ability to transcribe audio using Microsoft's services at no additional charge. It can create transcripts for podcast for example and the accuracy and speed are quite good. Typically you can get 60 minutes of audio transcribed in under five minutes. Read this blog post and an audio demonstration of how you can do this at https://theideaplace.net/transcribing-audio-using-the-desktop-version-of-word-for-windows/

Currently, there is no limit to the amount of audio you can transcribe as long as you have an Office 365 subscription.
